



William Gill Theatre - Renovations Are Underway

After many months of planning, we are pleased to announce that renovations of the William Gill Theatre have begun. You may have noticed the dumpster and heavy machinery in the Village Hall parking lot or the flurry of activity and construction noise coming from the second floor of Village Hall. The William Gill Theatre has been a social cornerstone of the Village community and the facility has hosted musical, cultural and social events since its inception. However, as with all good things, the time has come to upgrade, repair, and expand the facilities and equipment. This is a very large undertaking. The Village was fortunate to receive financial assistance in the form of NY State grants from Senator Craig Johnson, Assemblyman Tom McKevitt and Congresswoman Carolyn McCarthy, all of which have been or will be the primary source of funding. The renovations began in early January and to date, the Theatre has been completely gutted and the electrical and structural work is underway. The Theatre refurbishment project includes upgrading the lighting and electrical systems, updating the AV control room, installing a new stage, fire shutters, fire escape awnings, rear fire exists, stage curtains, hardware, drapes, backdrops and carpeting. If all goes as planned, we hope to have the work completed by June and are planning a "grand re-opening" shortly thereafter. Residents are invited to stop by Village Hall and take a peek at the construction progress.

Department of Public Works Phase II Storm Water Management Program Storm Water Pollution Prevention & Pet Waste



Throwing pet waste in storm sewers is illegal. Federal, New York State and Local Municipal regulations prohibit illegal or "illicit discharges" to storm sever systems and are punishable by fine and/or imprisonment. Bagged or unbagged pet waste thrown in storm sewer grates, openings, drains, or manholes is an example of an illicit discharge, which is a major cause of water pollution.

Storm sewers are not connected to wastewater treatment plants or septic systems like the drains in your home. When pet waste is tossed into a storm drain or left on the sidewalk, street or yard, it is carried by rainwater through the storm sewer system directly into our local water bodies, without any treatment!

Pet waste is a threat to human and environmental health because it contains harmful bacteria and pathogens, some of which can cause serious diseases in humans. Pet waste also contains many other nutrient pollutants, which contribute to excessive algae growth in a water body, upsetting the delicate balance of the natural habitat.

Being a responsible pet owner means picking up after your pet. Here is how you can properly dispose of your pet's waste and prevent local water pollution:

- Flush It: The best way to dispose of pet waste is to flush it down the toilet. Just remember to remove the waste from the bag or the litter before putting it in the toilet.
- Scoop the Poop: Bag it and put it in the trash. Landfills are designed to safely handle substances such as dog waste and cat litter.

DID YOU KNOW?

- That there are an estimated 74.8 million dogs owned in the United States, which create 72.5 billion pounds of dog waste every year!
- That just one gram of pet waste contains an average of 23 million fecal coli form bacteria. Some of these bacteria can cause serious gastrointestinal infections, as well as infections to the ear, eye, and throat in humans.
- That as pet waste decomposes, it demands a high level of oxygen from water. This demand can suffocate fish and plant life by reducing the amount of oxygen available to them.

Storm water is runoff from rain and snowmelt. Under natural conditions, this water seeps into the ground. In urban areas, this water flows over impervious surfaces (paved areas and building rooftops); does not percolate into the ground; and accumulates debris, chemicals, sediment or other pollutants.
