The Village of New Hyde Park A Purple Heart Community

On Saturday, September 19, the Village Board held a public ceremony to recognize the Village of New Hyde Park a **Purple Heart Community**.

The front lawn of Village Hall was filled as the Village Board, local elected officials and dignitaries, members of the Veterans of Foreign War, American Legion, the Military Order of the Purple Heart, residents, and special guests joined together to honor Purple Heart recipients in the Village of New Hyde Park. This ceremony was held to recognize the contributions and sacrifices of all members of the United States Armed Forces, and particularly to those Veterans who gave their lives or have been wounded while serving in the United States Armed Forces.

The Purple Heart is a United States military decoration awarded to veterans wounded or killed, while serving on or after April 5, 1917 in the United States Military. The Purple Heart is the oldest military award still given to United States military members.

The Village of New Hyde Park is the first Village in New York to recognize its community a Purple Heart Community. This is a proud time for our Village, for our brave veterans, and for all residents. Deputy Mayor Lawrence Montreuil, Liaison for Veterans Affairs, worked with New Hyde Park resident and Purple Heart Recipient Michael Dolan to organize the ceremony. Mr. Dolan donated a Purple Heart Flag which was raised onto the Village flagpole at the ceremony to be flown on special occasions. The Board has also declared Central Blvd. "**Memorial Way**" with a Purple Heart designation and plans are underway for enhancements at the Veteran's Monument in Memorial Park.

Resident Parking Permits

R On Tuesday, December 1st, residents can begin to purchase the 2016 resident "R" parking permit at the Village Clerk's Office during regular business hours. Residents need to present a current driver's license and vehicle registration that reflects their Village address. If you are renting an apartment or house in the Village, please bring your current lease agreement.

For planning purposes, please keep in mind that Village Hall closes at noon on Thursday, December 31st and will be closed all day on Friday, January 1st. The 2016 resident parking permit must be affixed to your car by Monday, January 4th to be in compliance with Village parking codes. The annual fee remains unchanged at \$75. If you have any questions, please call the Village Clerk's Office.

In consideration of those residents who cannot come into Village Hall during the day to purchase a parking permit, the Village Clerk's Office will have extended hours and remain open through 8:00 PM on Wednesday, December 9th. We hope these evening hours provide you with additional opportunity to purchase the 2016 resident parking permit.

On Monday, November 30th, the field house at Memorial Park and at Nuzzi Field will close for the season. During the winter season, there will be no Park Attendants on duty and no public facilities available in the Park. We encourage all residents to continue to enjoy the Parks during the winter, but to plan accordingly since there will be no public facilities available.

Snow Removal



While it may seem a long way off, snow season is approaching fast. We all need to work together to ensure the roads are cleared in a safe and efficient manner. Here's how you can help:

- **Do not park on the street during snow events**
- **Minimize your travel during snow events**
- **Do not throw snow from your walkway or driveway onto the road**
- **Remove snow from your vehicle while it is still parked in your driveway and certainly before you travel**
- **Village Code requires residents and business owners to remove snow and ice from the sidewalk within 24 hours of the snow event**



Zoning Board, Architectural Review Board, and Village Board Public Hearings

Zoning Board of Appeals:

September 9, 2015

- 1335 Jericho Tpke. - An application to construct an adult daycare center and medical office on the 1st floor with insufficient parking was adjourned to October 14th.

October 14, 2015

- 1335 Jericho Tpke. - An application to construct an adult daycare center and medical office on the 1st floor with insufficient parking was withdrawn by the applicant upon being denied a Special Use Permit by the Village Board on October 6th.
- 1218 Jericho Tpke. - An application to renovate the 2nd floor apartments, construct two new apartments on the 3rd floor, renovate the existing restaurant and expand the 1st floor kitchen with insufficient off street parking. A decision is pending upon review and decision by Nassau County Planning Commission.
- 523 North 10th Street - An application by the homeowner to maintain a second kitchen on the 2nd floor of a single family home was granted.
- 1324 Jericho Tpke. - An application to demolish existing buildings and construct a new Harley Davidson Motorcycle showroom on the 1st floor with accessory offices on the 2nd floor and motorcycle repair and maintenance in the basement was postponed to November 12th pending completion of the Special Use Hearing. This site has insufficient parking and the applicant seeks a variance for 19 undersized parking spaces.

Architectural Review Board:

September 23, 2015

- 1603 Jericho Tpke. - Williston Park Eye Associates submitted plans to install three new signs, one sign on each side of the building. The signs were all within approved shape, font, and color, but only two signs per building are allowed under Village Code. Two signs were approved. The third sign was denied.
- 1017 Jericho Tpke. - Domino's Pizza submitted plans to remove the existing business sign and install an illuminated channel lettering sign with the corporate logo, directly onto the brick façade. The application was tabled in order to give the applicant time to submit a new design within Village Code guidelines.
- 45 Millers Lane - Plans were presented to demolish the existing home and construct a new two story, one family dwelling on a 40' x 124' lot with a front porch, rear deck, and outside cellar entrance. Materials and design were approved with the stipulation that the outside cellar entrance be removed and replaced with a side entrance.
- 1500 Park Avenue - Plans were approved to add a full 2nd floor over the existing 1st floor.

Village Board:

October 6, 2015

- 1324 Jericho Tpke. -A Special Use Hearing was held on an application to demolish existing buildings at Miller Brothers Plumbing and construct a new Harley Davidson Motorcycle showroom on the 1st floor with accessory offices on the 2nd floor and motorcycle repair and maintenance in the basement. The case was adjourned to November 17th. In late October, Harley Davidson requested a postponement to December 15th, which was granted by the Village Board.

October 20, 2015

- The Board approved to amend the Zoning Law Chapter 195 to include a new provision for reimbursable expenses. This provision requires the applicant to pay for expenses incurred by the Village during the application review process and before any building permit, special permit, or variance can be issued. In cases where expenses are minimal, the Board of Trustees may waive, by resolution, this requirement.

Village Tax Assessment

Village Grievance Day will take place on Tuesday, February 16, 2016. If you feel your assessment is higher than it should be, you are welcome to meet with the Village Tax Assessor who is available on Wednesdays from 9 AM to 12 Noon. Although an appointment is not required, it is advisable to call ahead. Extended hours will be held on February 16th from 6:00 PM - 9:00 PM and an appointment is required. The Tax Assessor will review your current assessment and compare it to similar houses that have been recently sold in the Village.

If you file an Application for Assessment Adjustment, an inspection of the property will be required to ensure that the Building Department records are up to date. Unlike Nassau County Assessment, which can vary from year to year according to market value, Village assessments are not adjusted unless you make physical changes to your property or you grieve your assessed value.
