Building Department - Binu Pillay, Superintendent:

<u>ZBA</u>

- The last scheduled meeting of the Zoning Board and Appeals was held July 10th, with 2 cases heard that were approved.
- The next meeting is scheduled for August 14th and as of today no cases have been submitted, the deadline is 7/24/24.

<u>ARB</u>

• The last meeting of the Architectural Review Board was held on June 26th with 4 cases heard (which ranged from adding stone to the outside; amending a previously approved application which was conditionally approved; a new 2nd floor addition to a home (approved); and façade alterations to a commercial building which was approved.

Village of New Hyde Park

• The next meeting is scheduled for July 24th with 5 cases to be heard which is comprised of (2) new 2nd floor additions; change of siding; addition of a portico and roof; and a commercial sign application.

Planning Board

- The last meeting of the Planning Board was scheduled for June 26th; however, no applications were submitted and the meeting was cancelled.
- The next meeting is scheduled for July 24th and as of this time we have no applications submitted.

VILLAGE COURT

- The last Village Court was held yesterday, July 17th with 12 cases, which comprise of 1 parking on the lawn; 4 property maintenance; and 7 working without a permit.
- The next village court will be held on Aug. 21st, with 16 cases, which comprise of 1-obstructing sidewalk; 7 Property Maintenance; 7 Working without permits; and 1 multiple-family in a single family.

RENTAL REGISTRATION

• Rental registration is in process and inspections are being conducted accordingly.

SPECIAL USE

- There was no special use cases heard last month or tonight.
- During the period from 6/17 to today, the building department issued 28 permits: 9 building permits; 5 plumbing permits; 1 Roof; 3 Sidewalk/Driveway; 3 Fence; 6 Street Opening; and 1 demolition.
- 2 Certificates of Approval; 5 Certificates of Completion; and 1 Certificate of Occupancy.

• Waiting on MTA for a schedule on when new application to the cement façade will be applied.

Paving and Striping of 2nd and 3rd Ave.

- Striping on 2nd and 3rd Ave is complete
- That includes re-striping on 3rd Ave.
 - Thank You Binu and Igor for coordinating and completing!

<u>Signage</u>

- There is signage missing on 3rd Ave., specifically "One Way" signage.
 - Signage has been delivered and waiting on installation.

LIRR Track Work

- MTA/LIRR continues signal and switch work on the mainline
- Work was scheduled for the weekend, June 21st June 23rd, but has been postponed
- We will post the Work Schedule on the E Board and Website as soon as we find out

Water Authority

- The Water Authority is ordering up a new reactor for Well 57A to get it to 100% capacity, currently operating at 73%.
- Design work continues for the 3rd AOP reactor needed at Station 57 for well 57A.
 - We are also applying for a NYS Grant to offset the costs of this 3rd reactor
- Well 40 and 40A design and submittals are in process.
 - This work will include the installation of 2 AOP Reactors and 4 GAC vessels to treat emerging contaminants.

Village of New Hyde Park

- Since Station 40 (HQ) is also within New Hyde Park it will impact the residents of the Village of New Hyde Park as well as the North Hempstead New Hyde Park residents.
- Physical work is still scheduled to start September 2024.

Noise Abatement

- Last TVASNAC Meeting was June 24th. The next meeting will be on July 22nd.
- Meetings are held at the Hempstead Town Hall and start at 7 pm.
- Town of Hempstead attorney has filed a foil request to the FAA for the raw data from noise monitors placed along the departure and arrival routes of planes going into JFK. The FAA reported that the town will receive these reports on July 29th.
- If response is not received, Town of Hempstead and North Hempstead will move forward with Legal Action. TVASNAC is always pressuring the Port Authority and the FAA to limit the number of Flights over our community and to alternate runways. Also not to schedule flights late at night or early mornings.
- Residents are urged to file online noise complaints at <u>www.hempsteadny.gov/TVASNAC</u>; or for Hempstead residents to call 1-800-225-1071, North Hempstead residents dial 311.

Veterans Affairs/American Legion Post 1089

- The next meeting will be September 14th at 10:00 am at Village Hall
- Although there are no Post Meetings, we are planning for our fall activities which includes the Street Fair, Veterans Day, and a Legion Pancake Breakfast. The Pancake Breakfast is scheduled for Nov 10th and coincides with our Veterans Day Weekend.

- Eagle Scout Project Life Scout Michael Domingo Memorial Wall to honor those who gave the ultimate sacrifice for our Freedom. The wall is built and all the Plaques are in. We will now coordinate to get the plaques installed. The overall unveiling is scheduled for Sept 14, 2024.
- For the summer the Scouts headed out to their Annual Summer Camp at Onteora Scout Camp and we have a group of 8 Scouts that are heading to Sea Base in Florida.

Grants:

Justice Court Assistance Program (JCAP) Grant:

- We applied for \$25,000 in October 2023 and approved for \$18,885 in March 2024

Community Development Block Grant (CDBG):

 - Binu is currently getting estimates

• The Summer concert was a great success and the food trucks were a hit

Summer Camp

- The Village Children's Summer Camp is on-going and will run thru August 8th
- During the heatwave we have the sessions in the Village Hall where kids enjoy games and/or watch a movie
- Please have your child bring water to the camp, it's hot
- Every Thursday is water day so dress your child accordingly

Mayor Christopher Devane

Hero's Memorial Wall

- We will do the unveiling of the Wall of Heroes on Saturday, September 14th with a rain date of Sunday September 15th.
 - We are in the planning phase and will give more details in August.

<u>Lots</u>

- Brooklyn Avenue there will be a one-hour time limit
- 2024 is our construction year. We already started on the Central Avenue dealing with some flooding issues and some drainage issues on Lakeville. Both lots are going to be repaved starting Wednesday, July 24th.
 - Cars will need to be removed starting Tuesday at 6pm through Monday morning, July 29th
 - The plan is to bring back the Farmers Market to the Central lot next year
- Brooklyn lot will be next will take more work
- Looking to put up parking stations or poles in the parking lot which are very expensive
- Everyone needs to do a better job with the cleanliness of the parking lots

Street Fair

- Cheryl is working on the plans for the 2024 Street Fair
- The Chamber was told that they were going to be charged if the Business is not in the Village of New Hyde Park and wanted to know the reason
 - Last year there were over 150 vendors and historically, in an effort to get more vendors, there was no charge
 - There are expenses associated with the street Fair to the tune of \$20,000 that are picked up by the Village and Craft-A-Fair; DPW, i.e. overtime, tables, chairs etc.
 - We have no intention of making money on this event
 - Village Businesses, weather in the Chamber or not, will not have a charge.
 - Non-Village Chamber members who want a space on the sidewalk, will have a \$75 charge.
 - This is cheaper than other Villages and going on the street
 - If your Business/Organization is outside of the Village, there will be a fee to participate in the Street Fair, no exemptions
 - Mayor Devane then presented a check for \$200 to sponsor the participation fee for the following Non-Profit Organizations: Boy Scout Troop 298; The New Hyde Park Fire Department; the VFW and the American Legion

Village of New Hyde Park

- The Mayor wants it put on the record that the incoming President of the Chamber of Commerce, Cheryl Fajardo, thinks the rates and the fees are reasonable
- He also wants a 'Thank You' on the record to Ralph Ventura and the Pallisco Family for being vocal supporters of what we are doing with the Street Fair and the rates we are charging

Facilities - Village Hall

- Continue to get very good reports on the color
- We are very animal friendly. Anthony, the painter, noticed a bird's nest over the front door with young birds in it. Anthony was able to drill a hole in the and we now have a bird's nest on the side of the building
- We are working on a new Village Hall sign
- We met with the Cellini Lodge because the monument needs to be moved; and we are working together to make it happen.
 - The platform from the monument will need to go away and the monument will be moved forward towards Jerich Turnpike so Marcus Christ Hall can be moved forward.
 - We are going to preserve the globe and the plaques and make it beautiful

300 S 12th Street

- We received a text from the Governor's Regional Representative and he said that they will be reaching out to us regarding the Grant; glad you are able to get this going and we are ready to close on that property together
- There is still some environmental work that needs to be done on the sock factory that which is being worked out with the owner
- In terms of the order of the work that needs to be done: purchase the old sock factory and close on it; then demo the cleaners, laundromat and sock factory and convert it into a parking lot; and we will then move into the park area and start the park
 - We've already been in contact with Landtek and a Design Firm that has made a presentation

<u>DPW</u>

• The work is under construction.

Memorial Park

- We received calls about closing Memorial Park. The process is that the Mayor, Tr. Savarese and Frank, who runs the park, review the weather conditions every morning. When there is an air quality alert advising people to stay indoors and a high temperature humidity warning, there is no need to keep the park and the dog park open. During the heatwave, for the safety of the public and the children, a decision will be made to close the park.
- Additionally, during the Summer Camp hours, the park is supposed to be closed till 4:30 anyway so this really should not impact the residents.
- During the heat wave the Summer Camp is moved from the park to the Village Hall

The meeting was opened up to the Public and the Mayor addressed questions/concerns from the audience.

The meeting was adjourned at 8:05 PM and a motion was made by Deputy Mayor Nijjar, seconded by Tr. Savarese, and unanimously approved, to go to an Executive Session. The Executive Session ended at 8:30 PM.
