- 1. Fee **MUST** be paid at time application is filed.
- 2. All fees are non-refundable.
- 3. All blanks on the application are to be filled in. If an item is "not applicable", note as N/A. **LEAVE NO BLANKS.** ***PLEASE PRINT***
- 4. All applicants are subject to village board approval. Certain applications are issued at the discretion of the village clerk pending Board approval.
- 5. A Dumpster Permit is required regardless of the physical location of the dumpster, be it on the street or on your property.
- 6. No license or permit will be issued if the applicant, business, or a principle of the corporation submitted the application has any outstanding unpaid violations due the village.
- 7. The permit issued by the Village Clerk must be readily available and shown to any Village designated authority.
- 8. Pursuant to Village Code § 57-8.0.5, all applicants must use a Village licensed carter for the benefit, safety and general welfare of the public.
